

METHODISTS WIN LOP-SIDED CONTEST.

U. S. C. WON the field meet with St. Vincent's College yesterday afternoon on the grounds of the university by the lop-sided score of 82 to 40.

The field day was a tame affair as far as records were concerned. Parsons of U.S.C. won each of his events handily. The time was poor except in the 100 and 220-yard dashes. Parsons concluded the first sprint in 10 2-5, and the other in 22 2-5 seconds.

Elliott of U.S.C. showed fine fettle by winning both of the hurdle races in respectable time. Curl was a surprise in the 880-yard and mile runs, winning both. Hubbard lost the two-mile test to Bernard of S.V.C. in one of the prettiest finishes of the day. "Hubby" was in the lead until the final sprint for the tape, when Bernard shot past him like a flash. The U.S.C. runner recovered some of his lost ground and both reached the tape neck and neck with the S.V.C. man a few inches in the lead.

Fergusson of U.S.C., in the weights was entirely out of form, and though he took first place in both the hammer and the shot puts, his performance was below his usual standard.

The pole vault was interesting and was fought to a conclusion by Wilhoit and Comstock. The bar went up to 10 feet and both men stayed in. At 10 feet 5 inches Comstock of U.S.C. went out with a badly-sprained ankle and Wilhoit, the star of the S.V.C. team, cleared the bar easily at 10 feet 7 inches, setting a high mark for pole vaulting in the South.

Wilhoit won the high jump, but in the broad jump the work of the day told seriously on the man who had performed so well for his college and two men outjumped him. The relay race went easily to U.S.C., Parsons finishing in a walk.

There was scarcely any enthusiasm as the result was announced as the

contest had developed, early in the day, into a dreary procession with the Methodists far in the lead. A cold wind blowing across the bleachers was uncomfortable for the spectators who sat and shivered as the fourteen events were dragged off in slow order.
